Today, i.e. 18/01/2025, a joint teams comprising Kangpokpi District Police, B/133 Bn & C/133Bn. CRPF, SDO Island Block led by Shri Tholu Rocky, MPS, Addl SP (L&O)/Kangpokpi under the supervision of SP/Kangpokpi proceeded from SKL-PS at 6:30 am for carrying out poppy destruction drive in the hill ranges of Y. Langkhong Village, Kangpokpi District. The joint teams reached the spot at 08:30 am and successfully destroyed the illegal poppy plants of about 26(twenty Six) acres at 3:00 pm. The approximate value of the destroyed poppy plants is Rs. 2,90,00,000/- (Two crore and Ninety lakhs appx). The teams arrived back at 5:20 pm on the same day.

Hence, a suo-motu case under FIR No. 1(1)2025 SKL-PS u/s 18(b) ND & PS Act, 1985 is being registered for investigation.
