Subject : Submission of recovered weapons and ammunitions.

Sir,

I am to report the recovery and subsequent submission of cache of weapons , ammunitions and explosive as a part of an operations conducted by a joint team of 22 Assam Rifles Saikul Post and Saikul -PS in accordance with the specific input received on 16 June 2024.

On the aforementioned date specific input was shared by intelligent agency regarding a presence of cache of weapons , ammunitions and explosives in the general area of foothills of Gangpijang Hill ranges( SQ4710) 8 km south from Saikul COB . In response to the information, a column of one Officer, one JCO and twenty others ranks of 22 Assam Rifles Saikul post assisted by Saikul -PS personnel launched a search operation at 0930 hrs in the general area of foothills of Gangpijang Hill ranges ( SQ4710). At around 1100 hrs a suspicious patch covered with foliage was found. The team removed the foliage using a long stick and found cache of weapons and ammunitions.

After conducting a meticulous search for two hours the following weapons, ammunitions and explosives were recovered at 1115 hrs.

- (a) 01 x 7.62 mm AK 56 Asslt Rif(Regd no-23040).
- (b) 01 x Pt 22 Rifle.
- (c) 01 x 12 inch Single Bore Brl Gun.
- (d) 02 x Improvised Projectile Launchers (Lot no-JOJJ)

- (f) 01 x Country Made Hand Grenade
- (g) 03 x7.62mm 3 knot 3Live Rds.
