Sir,

In a follow up action to wpn looting incident of IRB Outpost loc at Y Jn (SQ 4406) input was recd fro own sources regarding possible presence of looted wpn in Hen A Mark hill (SQ 4207) approx 2 Kms east of Thingsat village under Saikul Police Station A jt search OPS was undertaken to retrieve those wpns launched at 0600 hrs on 03 sep 2024

2. Own column i.e 22 Assam Rifles ex COB Motbung str 02/02/30 and Police reps from Sapermeina PS were part of the Ops through search of the Gen A as well as surrounding hill areas were carried out that resulted in recovery of arms, amns and eqpts. Details of the same is as follow :-


