12. First Information contents :

Today, i.e. 31/01/2025, at 8: 00 am, District Police Kangpokpi, 2(two) Coy of 133 Bn. CRPF, SDC Saikul led by Addl SP (L&O)/Kangpokpi under the supervision of SP/Kangpokpi reached Lhungjang Village for Poppy plant destruction. At around 8:20 am when the destruction team ascended the hill ranges unknown local public men & female numbering about 85 formed unruly mob and started damaging four light vehicles breaking the front windshield and door glass of Police by using sticks and threatened the Police & CAPF at the parking ground taking advantage of less presence of vehicle protection team. In that the mob showed sharp knives, long wooden stick, Petrol filled bottles and intimidated the security personnel to leave the village without destruction of Poppy plants. Seeing the situation tense the advance team which ascended the hill ranges returned the parking ground and control the mob tactfully and dispersed. The criminal action of unknown mob tantamount to criminal intimidation of security personnel, damaging the Public property and obstruction on lawfull duty.

Hence, a Suo-motu case under FIR No. 4(1)2025 SKL-PS u/s 191(2)/191(3) /324(4) /351(2)/3(5)/132 /3/4 PDPP ACT is being registered for investigation.




