

12. First Information contents :

Today, i.e. 25/02/2025, a joint teams comprising Kangpokpi District Police, 4 Coys of 133Bn. CRPF, Forest Division Kangpokpi SDC Saikul Block led by Shri Abhinav, IPS, SDPO SPM, Kangpokpi under the supervision of Shri, Manoj Prabhakar, IPS Superintendent of Police, Kangpokpi District, proceeded at Naphai Village at 0830 Hrs for carrying out Poppy destruction drive in the hill ranges of Naphai Village, Lhungtin Sub-Division, Kangpokpi District. The joint teams reached the spot at 0900 Hrs and successfully destroyed the illegal Poppy plants of about 35 (Thirty five) acres at 1500 Hrs. The approximate value of the destroyed Poppy plants is calculated at about Rs 3,90,00,000/- (Three crore and Ninety lakhs) appx. The teams arrived back at 1530 hrs on the same day.

Hence, a suo-motu case under FIR No. 6(2)2025 SKL-PS u/s 18(b) ND & PS Act, 1985 is being registered for investigation.


