12. First Information contents :

Today, i.e. 28/02/2025, a joint teams comprising Kangpokpi District Police, 4 Coys of 133Bn. CRPF, Forest Division Kangpokpi SDC Saikul Block led by Shri Abhinav, IPS, SDPO SPM, Kangpokpi under the supervision of Shri, Manoj Prabhakar, IPS Superintendent of Police, Kangpokpi District, proceeded at Ethoi River and Hills Ranges of Puleijang village at 0900 Hrs for carrying out Poppy destruction drive at Ethoi River and Hills Ranges of Puleijang village, Lhungtin Sub-Division, Kangpokpi District. The joint teams reached the spot at 0930 Hrs and successfully destroyed the illegal Poppy plants of about 30 (thirty ) acres at 1600 Hrs. The approximate value of the destroyed Poppy plants is calculated at about Rs 3,50,00,000/- (Three crore and fifty lakhs) appx. The teams arrived back at 1630 hrs on the same day.

Hence, a suo-motu case under FIR No. 8(2)2025 SKL-PS u/s 18(b) ND & PS Act, 1985 is being registered for investigation.




