



Sir,

I have the honour to state that, today i.e. 26/01/2026 @ 12:30 pm, a random frisking and checking was conducted at T/Khullen Naka Check Point, about 11 Kms South of SPT-PS along NH-2 by SOT (Special Operation Team) Senapati Police along with D-78 and B-109 QAT Team CRPF. While frisking and checking, one vehicle Auto Taxi bearing Regn. No. MN03-1487 was seen coming from Imphal side towards Senapati. The said vehicle was stopped for frisking and checking. On enquiry, the driver of the vehicle identified himself



Pasang Serpa (56) yrs s/o Nangel Serpa of Mothing Nepali, Kangpokpi. On checking the vehicle, suspected Opium were found in the bags of Mohan and Subash (Name changed as they are Juvenile) of Katomei Part-0 Nepali. As such DC/KPI was intimated by my senior Officer and a request was made to depute one magistrate. Accordingly, SDC Kangpokpi Shri. K. Lunlemoi Vaiphei, (Executive Magistrate) was deputed for doing the necessary procedures.

On arrival of the Executive Magistrate and in his presence and in the presence of Mohan and Subash, their bags were thoroughly checked. On checking, the black bag (marked as Addidas) which is in the possession of Mohan, suspected opium was found inside the eleven containers of Gobind Tobacco MFG. CO. Also, on checking the grey bag which is in the possession of Subash, suspected opium was found in five containers of Gobind Tobacco MFG. CO.

The suspected opium in 11 (eleven) and 5 (five) containers were weighed in the presence of Mohan, Subash and the Executive Magistrate. The total weight of the suspected opium found in the possession of Mohan in 11 containers were 350 grams including the weight of containers and the total weight of suspected opium found in the possession of Subash in 5 (five) containers were 160 grams including the weight of containers. The total weight of the suspected opium in 16 (sixteen) were 510 grams including the weight of containers. The approximate value is Rs. 35, 700/- (Thirty-five thousand seven hundred). The 16 containers containing suspected opium were seized in the presence of the Executive Magistrate and witnesses by preparing a formal seizure memo. The detained persons were formally apprehended by observing formalities at 1:50 pm. During the seizure and arrest, videos or photos was not uploaded in eSakshya as I don't have an authorized eSakshya account. However, I have recorded the video of the seizure and arrest in the phone. As no civilian is willing to be the independent witnesses, seizure and arrest is made without independent witnesses.
