I have the honour to state that today i.e 21/01/2025 @ 1:00 pm, received a reliable information from our own sources regarding movement of a vehicle carrying narcotic substance at Biisho-Tadubi Road. On receipt of the information, joint naka post at Tadubi Police Station Drop Gate and combine team consisting of Tadubi Police led by OC, Inspector Lamkhosat Kipgen, 2(two) columns of BNHQ strength 02/05/15 Ors and 1(one) column of B-Coy Mao Post strength 01/01/15 Ors of 16 AR and SOT under the supervision of SP Senapati intercepted one Bolero white in colour bearing registration No NL07CB-1151 driven by one Mr. Avio S(47yrs) s/o Salouni of Katafiimai Village, P.O-Tadubi, P.S-Tungjoy, Senapati District, Manipur-795104. Following which, I have informed to my senior officer. As such DC/SPT was intimidated by my senior officer and a request was made to depute one magistrate. Accordingly, SDO/Tadubi Smt. Pf. Lophro (Executive Magistrate) was deputed for doing the necessary procedures.

On arrival of the Executive Magistrate and in her presence and in the presence of the driver namely Mr. Avio (47yrs) s/o Salouni of Katafiimai Village. The vehicle was thoroughly checked. On checking 20(twenty) soap cases of suspected brown sugar were found concealed under the left back seat and the left side body of the said vehicle.

The 20(twenty) soap cases suspected to be brown sugar were weighed in the presence of the executive magistrate, the driver and witnesses. The weight of 20(twenty) soap cases suspected to be brown sugar is 805 gms including with soap cases cover. 
