I have the honour to state that today i.e. 26/02/2026 at about 10:10 am, a reliable information was received from our own source and further corroborated from the information input provided by 33 AR regarding the presence of some active cadres of PREPAK (Pro) organization (a faction of PREPAK organization), an outlawed banned organization, in and around Ghari area of Imphal West District with a view to commit prejudicial activities. Based on the information and with the permission of the authority, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri P. Achouba Meetei, MPS, Dy. SP (CDO), IW and under the supervision of Shri. N. Suraj Singh, MPS, Addl. SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted search operation at Ghari area. During that one suspected person was detained at **Ghari near Modern English High School** for verification. On spot verification, the detainee identified himself as **Thokchom Raj Singh (25 yrs) @ Ibungo S/o. Th. Hemchandra Singh of Wangjing Laming Thokchom Leikai, Thoubal District, Manipur.**

During preliminary verification, he disclosed that he is an active member of PREPAK (Pro) organization (a faction of PREPAK organization) and presently working under the command of one s/s Commander Taibanganba (Ph. no. 6909156313 / +959407008979 / +959407009008 / 7642800575 / +959985649674) of PREPAK (Pro) organization from Wangoo area who is presently staying in Bangladesh. He also disclosed that under the instruction of his commander, he was involved in extortion activities by receiving extortion money from general public by using his Gpay number 9233234258 for raising their party fund and he further sent money to the cadres/members of their party by using his Gpay number 9233234258 to be used in their party activities.

Hence, he was arrested from the spot i.e. at Ghari near Modern English High School at 11:48 am by observing formalities. From his possession, (i) one Redmi Note 13 5G mobile handset along with two SIM cards i.e., (a) one Jio SIM card bearing mobile no. 9366438114 (as disclosed by him) and (b) one Airtel SIM card bearing mobile no. 9233234258 (as disclosed by him) and (ii) one Aadhaar card bearing no. 4158 5380 7574 were seized at the spot at 11:54 am by observing due formalities.

Hence, the arrested person and the above seized articles are handed over to you for taking further necessary legal action against him.
