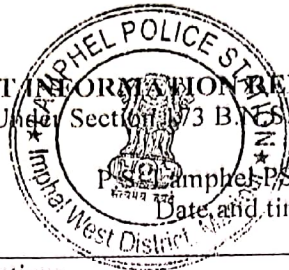

With due respect and humble submission, I the under-signed namely Meigai Kamei, bring forward for your kind consideration and favorable action statin herein below that: -

1. That the undersigned is the permanent resident of Gangluan Village. Part II. The undersigned village i.e Gangluan Village is divided into 5 (five) hamlets, namely (i) Gangluan Banglajang [Gangluan Part- 1]: (ii) Gangluan Kaipi [Gangluan Part II]: (iii) Gangluan Longlei @ Nungleiband [Gangluan Part III]: (iv) Gangluan Longlei Apinjang [Gangluan Part IV]; and (v). Gangluan Duangailong [Gangluan Part - V].
 2. That, on i.e 26/02/2026 at around 10 a.m, around 100 persons approximately led by the aforesaid 22 (twenty-two) persons (herein after referred to as the crowd) came to my residence, pucca/semi pucca structure and had partially dismantled my house/residence and also fire some rounds of fire arms.
 3. That, the crowd led by the aforesaid 22 (twenty-two) persons had damaged my properties inclusive of movable and immovable properties. It is pertinent to mention herein that the inventories of the damaged properties either movable or immovable properties could not be ascertained as of now.
 4. That, the crowd with criminal conspiracy and criminal intimidation trespass my house/residence and started breaking / dismantling the same without any provocation from my end.
 5. That, your good self may kindly register and FIR against the aforesaid 22 (twenty-two) persons and their counterpart who are involved in the damaging of my property either movable or immovable properties as well as for threatening with dire consequences as per the relevant law of the land under the Bharatiya Nyaya Sanhita, 2023 and the Arms Act. 1959.
- In view of the facts and circumstances of the incident, it is therefore most respectfully requested that an FIR may be registered against the aforesaid 22 (twenty-two) persons and

their counterpart who are involved in the damaging of my property either movable or immovable properties as well as for threatening with dire consequences as per the relevant law of the land under the Bharatiya Nyaya Sanhita, 2023 and the Arms Act, 1959, in the interest of justice.
