I have the honour to report that today i.e. the 20th January, 2026 at about 10:00 a.m. received a reliable information from our own source corroborated with the intelligence of 7 Madras Regiment about the presence of an active member of the outfit KCP at Nongada area of Imphal East. Based on the said information and with the permission/authorization of the authority, a combined team of CDO/IE Unit and a column of 7 Madras Regiment and 4 Mahar Regiment conducted a C.I. Ops. at the said area under the command of Inspt. Anilchandra Mutum, Officer-in-Charge CDO/IE Unit, supervised by Shri. Y. Joyraj Singh, Addl. SP(Ops) IE and under the overall supervision of Shri. Shivanand Surve, IPS, Superintendent of Police Imphal East District at 11:00 a.m.

In that, one suspicious unknown person was detained for spot verification and checking at Nongada Makha Leikai near Community Hall, Imphal East District. On checking the detainee body, one mobile phone was found and recovered from his possession. On verification, the detainee identified himself as one **Senjam Bosco Meitei @ Tamba (25 years) S/o (Late) S. Bikram Meitei of Nongren Mamang Leikai, Lamlai PS, Imphal East District.** On further verification, the detainee stated that he is an active member of the outfit KCP (PSC). The detainee further stated that, he joined the said outfit through one Mrs. Josika of KCP (PSC) in the month of October, 2024 and presently working under his command. The arrestee is presently working under the command of one Mr. Pari of KCP (PSC).

So, the detainee was arrested from the spot i.e. Nongada Makha Leikai near Community Hall, Imphal East District at 11:39 a.m. and seized one mobile phone (TA-1557) bearing IMEI no. 352714204086292 & 352214204086300 along with one Airtel SIM card having phone no. 8415938494 from his possession at the spot i.e. Nongada Makha Leikai near Community Hall, Imphal East District at 11:45 a.m. by observing due formalities.

Therefore, the arrested person along with the seized mobile phone is being handed over to you for taking up further necessary legal actions against him.
