Sir,

I have the honour to report that today i.e., the 20th January, 2026 at about 4:00 p.m. received a reliable information from our own source corroborated with the intelligence II Wireless and 31 AR about the presence of an active cadre of the outfit PREPAK at Sawombung Wairi area of Imphal East. Based on the said information and with the permission/authorization of the authority, a combined team of CDO/IE Unit and 31 AR conducted a C.I. Ops. at the said area under the command of Inspt. Anilchandra Mutum, Officer-in-Charge CDO/IE Unit, supervised by Shri. Y. Joyraj Singh, Addl. SP(Ops) IE and under the overall supervision of Shri. Shivanand Surve, IPS, Superintendent of Police Imphal East District at 5:00 p.m.

In that, one unknown suspicious person was detained for spot verification at Sawombung Wairi near Brojen Brick Field, Imphal East District. On verification, the detainee identified himself as one, **Kangjam Milan Meetei @ Somendro @ No. 1 @ Ibungo (33 years) S/o (Late) K. Tomba Meetei of Sekmaijin Khunou Kangjam, Hiyanglam PS, Kakching District A/p – Sawombung Wairi, Imphal East District**. On further verification, the detainee stated that he is an active member of the outfit PREPAK (VC) group, joined through one Mr. Brojen of PREPAK (VC) in the year 2008 and got his basic military training in the same year for 45 days at Thanga Karang, Bishnupur District, Manipur under the command of one s/s – Corporal Mr. Semdokpa of PREPAK (VC) with allotted army no. 280535 of 28th batched.

So, the detainee was arrested from the spot i.e. Sawombung Wairi near Brojen Brick Field, Imphal East District at 5:39 p.m. by observing due formalities. Therefore, the arrested person is being handed over to you for taking up further necessary legal actions against him.
