Sir.

I, Kshetrimayum Ranitombi Leima W/o Kshetrimayum Ibomcha Meitei, resident of Village Chana, Tehsil Sawombung, District Imphal East, Manipur, wish to report the following offence:

1. Profile of Complainant: I am a senior citizen running a small grocery wholesale business from my residence. My son, Major Kshetrimayum Sanayairangchan Meitei is a serving officer in the Indian Army currently deployed on active duty in Ladakh. My daughter-in-law, who is 36 weeks pregnant along with her 5 year old daughter also resides with me along with my second son and my youngest daughter.

2. Brief Facts of the Case:

* Previous Threats: Since 22 May I have been receiving threats from unknown mobile numbers 7085577271, 8119919847 and the callers claimed to be cadres of the KCP, Miyamgi Fingang Lamni organization.

* The Incident: Today, on 27 Jan 2026, at approximately 14:30 hours, unknown miscreants trespassed into my residential shop compound and strategically placed a Suspicious Package (Suspected Explosive) along with a Threat Warning Letter. 2 (two) unknown miscreant with face covered arrived at our shop in a bike (red in colour). One of them entered and asked me about buying some items and left immediately after I responded to him that the items were not available at the moment. And after few seconds, one of them came back and kept the suspicious package (black polythene) on a stool (Mora) and left immediately. I asked him where they came from and he mentioned Sekta village in low voice.

3. Nature of Threat: This is perceived as a kinetic attempt to cause an explosion in a civilian area. The act has caused severe mental trauma to my family, especially my pregnant daughter-in-law, putting her pregnancy at medical risk.

4. Suspects: I suspect the individuals operating the mobile numbers mentioned above are directly involved in planting this device.

5. Request: I request you to:

- Register an FIR under the relevant sections of the Explosive Substances Act, Unlawful Activities (Prevention) Act (UAPA), and Criminal Intimidation IPC.
- Immediately investigate and apprehend the miscreants to bring them to lawful justice.


