Subject: FIR regarding criminal intimidation and threat to forcibly evict residents of Shangkai Village.

Sir,

I, L. Jangkhoao Khongsai, Secretary of Shangkai Village Authority, Ukhrul District, Manipur, hereby lodge this FIR on behalf of the residents of Shangkai Village regarding a serious act of criminal intimidation and threat to the safety, life, and property of the villagers.

On 12/03/2026, an organization identifying itself as “Khanuithot Khon – Voice of the Naga Youth” circulated a written notice titled “Ultimatum: Notice to Vacate Shangkai Village.” Through the said document, the group has issued a final ultimatum directing the residents of Shangkai Village to vacate the village immediately, and further threatened that failure to comply would compel them to take “all necessary measures to ensure immediate removal from their territory.”

The language and contents of the said ultimatum clearly amount to criminal intimidation, threat of violence, and an attempt to unlawfully and forcibly evict the residents of Shangkai Village from their homes and ancestral land. Such threats have created serious fear, panic, and insecurity among the villagers, including women, children, and elderly persons, and have the potential to disturb public peace and law and order in the area.

Issuing such an ultimatum and threatening forcible removal of civilians is illegal and punishable under relevant provisions of law relating to criminal intimidation, threat to life and property, and acts likely to cause breach of peace.

In view of the above, I humbly request your good office to:

1. Register an FIR against the individuals or organization responsible for issuing this ultimatum.
2. Initiate immediate investigation and take appropriate legal action against those involved.
3. Provide necessary security and protection to the residents of Shangkai Village to prevent any untoward incident or act of violence.

A copy of the said ultimatum notice is attached herewith as evidence for your reference and necessary action.

I request your immediate intervention to uphold the rule of law and ensure the safety and security of the villagers.
