Sir,

I have the honour to report that today i.e. the 5th February, 2026 at about 3:00 p.m. received a reliable information from our own source corroborated with the intelligence of 33 AR about the presence of an active cadre of the outfit PREPAK at Itam Nungoi area of Imphal-East District. Based on the said information and with the permission/authorization of the authority, a combined team of CDO/IE Unit and 33 AR conducted a C.I. Ops. at the said area under the command of Inspt. Anilchandra Mutum, Officer-in-Charge CDO/IE Unit, supervised by Shri. Y. Joyraj Singh, Addl. SP(Ops) IE and under the overall supervision of Shri. Shivanand Surve, IPS, Superintendent of Police Imphal East District at 4 :00 p. m.

In that, one suspicious unknown person was detained for spot verification at Itam Nungoi, near The Newly Shining Kid Dynamic English School, Imphal East District. On verification, the detainee identified himself as Konhoujam Deepak Meitel @ Konthou (26 years) S/o Konhoujam Sanjit Meitel of Pungdongbam Awang Leikai, Lamlai Police Station, Imphal East District. On further verification, the detainee stated that he is an active cadre of the outfit PREPAK (Pro), an alliance of G5, joined through one s/s 2nd Lieutenant Mr. Khongnangthaba of PREPAK (Pro), an alliance of G5, in the month of January, 2024, and got his basic military training for 25 days with

 allotted army no. S17JAV24 of 2nd batch of 2024 under the command of one Mr. Chingkhei of PREPAK (Pro), an alliance of G5. The detainee is presently holding the rank of s/s Private and working under the command of one s/s - Colonel Mr. Iko of PREPAK (Pro), an alliance of G5.

So, the detainee was arrested from the spot i.e. Itam Nungoi, near The Newly Shining Kid Dynamic English School, Imphal East District at 4:29 p.m. by observing due formalities.

Therefore, the arrested person is being handed over to you for taking up further necessary legal actions against him.
