Sir,

I have the honour to report that today i.e. the 14th February, 2026 at about 4:00 a.m. received a reliable information from our own source corroborated with the intelligence of 165 TA and 31 AR about the presence of an active cadre of the outfit PREPAK at Nungoi area of Imphal-East District. Based on the said information and with the permission/authorization of the authority, teams of CDO/IE Unit conducted a C.I. Ops. at the said area under the command of Inspt. Anilchandra Mutum, Officer-in-Charge CDO/IE Unit, supervised by Shri. Y. Joyraj Singh, Addl. SP(Ops) IE and under the overall supervision of Shri. Shivanand Surve, IPS, Superintendent of Police Imphal East District at 5:20 a. m.

In that, one unknown suspicious person was detained for spot verification at a house at Nungoi Makha Leikai, Imphal East District. On verification, the detainee identified himself as one **Irengbam Saratkumar Meetei @ Achouba @ Henthoiba (21 years) S/o I. Mantri Meetei of Nungoi Awang Leikai, Lamlai Police Station, Imphal-East District**. One mobile phone was recovered from his possession. On further verification, the detainee stated that he an active member of the outfit PREPAK joined through one Mr. Ningthem of PREPAK in the month of September, 2024 and got his basic military training for 30 days of 2024 batched under the command of one s/s – Lance Corporal Mr. Wangbren of PREPAK. The detainee further stated that he is presently holding the rank of s/s Private and working under the command of one Mr. Freedom of PREPAK.

So, the detainee was arrested from his residence i.e. Nungoi Makha Leikai, Imphal East District at 5:53 a.m. and seized *one mobile phone (Iphone 15) bearing IMEI no. 350571681173049 & 350571681398505 along with one Airtel SIM card having no. +91 8132047962* at the spot i.e. Nungoi Makha Leikai, Imphal East District at 5:58 a.m. by observing due formalities.

Therefore, the arrested person along with the seized mobile phone is being handed over to you for taking up further necessary legal actions against him.


