Sir,

I have the honour to report that today i.e. the 14th February, 2026 at about 11:00 a.m. received a reliable information from our own source about the presence of an active cadre of the outfit PREPAK at Napetpalli area of Imphal-East District. Based on the said information and with the permission/authorization of the authority, a combined team of CDO/IE Unit comprising of by SI, Kh. Victor Singh and HC. Y. Binoykumar Singh of CDO/IE along with column of 8 Bihar Regiment conducted a C. I. Ops. at the said area under the command of Inspt. Anilchandra Mutum, Officer-in-Charge CDO/IE Unit, supervised by Shri. Y. Joyraj Singh, Addl. SP(Ops) IE and under the overall supervision of Shri. Shivanand Surve, IPS, Superintendent of Police Imphal East District at 12:20 p. m.

In that, one suspicious unknown person who came in a scooter was detained for spot verification and checking at Napetpalli near Oil Pump, Imphal East District. On checking the detainee body, one mobile phone and a sum of Rs. 600/- (six hundred rupees) were found and recovered. On verification, the detainee identified himself as one Ingudam Ingocha Singh @ Borobi (50 years) S/o (Late) I. Megho Singh of Seljang Makha Leikal, Yalngangpokpi Police Station, Imphal-East District. On further verification, the detainee stated that he is an active member of the outfit PREPAK Pro, an alliance of G5, joined through one Mr. Moyamba of PREPAK (Pro), in the month of August.

2023 and presently working under his command. On further checking the toolbox of the detainee scooter, 10 (ten) nos. of Visiting card of PREPAK (PROGRESSIVE) group, with the name Rocky, Finance Committee -1, Contact no. +91 8414091406 were found and recovered.

So, the detainee was arrested from the spot i.e. Napetpalli near Oil Pump, Imphal East District at 12:58 p.m. and seized; (i) 10 (ten) nos. of Visiting card of PREPAK (PROGRESSIVE) group, with the name Rocky, Finance Committee -1, Contact no. +91 8414091406. (ii) One Scooter (Honda Activa), grey in colour, bearing regd. no. MN-01L/7850 bearing Engine no. JF50E80635298 & Chassis no. ME4JF50IMD8636487, (iii) a sum of Rs. 600/- (six hundred rupees and (iv) One mobile phone (Mi 11X) bearing IMEI no. 868494050890132/22 & 868494050890140/22 along with two Jio SIM cards having phone no. 9366342641 & 6009847352 at the spot i.e. Napetpalli near Oil Pump, Imphal East District at 12:59 p.m. by observing due formalities.

On further examination of the arrestee it came to light that he kept conceal one pistol at his residence, inside his room, which was handed over to him by the said Mr. Moyamba of PREPAK-Pro an alliance of G5 about a week before. Immediately, our combined team along with the arrestee rushed to his house and on the instance and pointing of the arrestee; one .32 Pistol marked as '75705, MADE IN JAPAN' loaded with five live rounds in the magazine was seized from inside his room which was conceal under the carpet underneath an iron Almirah at about 1:09 p.m. from his residence i.e. Seijang Makha Leikai, Imphal East District by observing due formalities.

Therefore, the arrested person is being handed over to you for taking up further necessary legal actions against him.
