I, Thangminlen Lhungdim 41yrs S/o Ngamthang Lhungdim of Mongkot Chepu Village Ward No.2 have the honour to state that on 24th March 2026 at around 7:30 am while I was Sleeping faced a heavy attack on my village .The Tangkhul Militants fired a explosive bombs from the hill range of Sikibung (Sharkaphung) Tangkhul Village and also several automatic weapons were fire upon the village (Monkot Chepu). As a result of which the stray bullets hit my wall of the house and furniture's endangering mine and my family members lives leaving us traumatised.

It is therefore, requested to kindly take necessary legal action against the suspected armed miscreants of Tangkhul militants as per law and compensate the lost incurred.
