Received a telephonic information that on 21/2/2026 at about 9.55 am, it is reported that on the same day at about 9:50 am one namely Lalrenlakpam Brajabidhu Singh (70) S/O (L.) L. Bro Singh of Chingarel Tejpur Mayal Leikai causes serious injury to his wife namely Lalrenlakpam (O) Luhl Devi (64) Yrs W/O L. Brajabidhu Singh of Chingarel Tejpur Mayal Leikai with deadly weapons while his wife at his run shop located at Chingarel Tejpur along NH-202 Imphal Ukhrul road and run away from the scene by driving his Honda Dio. Further the injured person was evacuated to the nearby hospital for medical treatment.
