It is therefore, request to kindly taken up further legal action against the above mentioned accused person.

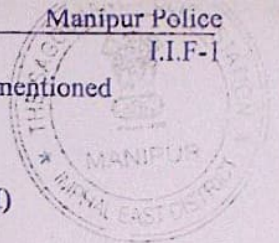
