Sir,

I have the honour to report that today i.e., the 22nd February, 2026 at about 4:00 p.m. received a reliable information from our own source corroborated with the intelligence of 8 Bihar Regiment about the presence of an active cadre of the outfit RPF/PLA at Yourabung area of Imphal-East District. Based on the said information and with the permission authorization of the authority, a combined team of CDO/IE Unit, and 8 Bihar Regiment conducted a C.I. Ops. at the said area under the command of Inspt. Anilchandra Mutum, Officer-in-Charge CDO/IE Unit, supervised by Shri. Y. Joyraj Singh, Addl. SP(Ops) IE and under the overall supervision of Shri. Shivanand Surve, IPS, Superintendent of Police Imphal East District at 5:00 p.m.

In that, one unknown suspicious person was detained for spot verification at a house at Yourabung Khunou, Imphal-East District. On verification, the detainee identified himself as one **Khundom Momocha Meitel @ Yaiphaba (31 years) S/o (Late) Kh. Rajen Singh of Yourabung Khunou, Lamlai PS, Imphal East District.** On further verification, the detainee stated that he is an active member of the outfit RPF/PLA joined through one through one Mr. Bikananda @ BK of RPF/PLA in the month of January, 2026 and presently working under command of one Mr. Sayon of RPF/PLA. The detainee further stated that, he is involved in recruiting new cadres to their outfit, extortion of money from tent-houses and passenger vehicles (TATA Magic) plying at Lamlai area of Imphal East District on the advice and command of the said Mr. Sayon of RPF/PLA.

So, the detainee was arrested from his residence i.e. Yourabung Khunou, Imphal-East District at 5:22 p.m. and seized one mobile phone (Redmi Note 8) bearing IMEI no. 8627 5904 1357 623 & 8627 5904 1357 631 along with two SIM cards having no. Jio +91 70054 32860 & Airtel +91 96129 01660 from his possession at the spot i.e. residence i.e. Yourabung Khunou, Imphal-East District at 5:25 p.m. by observing due formalities

Therefore, the arrested person along with the seized mobile phone is being handed over to you for taking up further necessary legal actions against him.
