Subject: Report.

Sir,

I have the honour to report that today i.e. the 23rd February, 2026 at about 10:30 a.m. received a reliable information from our own source about the presence of an active member of the outfit KCP at Lamlai area of Imphal-East District. Based on the said information and with the permission/authorization of the authority, a combined team of CDO/IE Unit, and 8 Bihar Regiment conducted a C.I. Ops. at the said area under the command of Inspt. Anilchandra Mutum, Officer-in-Charge CDO/IE Unit, supervised by Shri. Y. Joyraj Singh, Addl. SP(Ops) IE and under the overall supervision of Shri. Shivanand Surve, IPS, Superintendent of Police Imphal East District at 11:30 a.m.

In that, one suspicious unknown person was detained for spot verification at a farm-house at Lamlai Mamang Leikai Samu Lambel, Imphal East District. On verification, the detainee identified himself as one Khaidem Joychandra Meiteei @ Inaocha (55 years) S/o (Late) Kh. Chaoba Meitei of Lamlai Mayai Leikai, Lamlai Police Station, Imphal East District. On further verification, the detainee stated that he is an active member of the outfit KCP (MFL) group joined through one Mr. Naughtyboy @ Naoba of KCP (MFL) group and presently working under his command. So, the detainee was arrested from the farmhouse i.e. Lamlai Mamang Leikai Samu Lambel, Imphal East District at 12:41 p.m. by observing due formalities.

On further verification of the detainee, it came to learnt that he kept conceal some rifle ammunitions at his farm-house. On the production of the detainee; 50 (fifty) nos. of 7.62 x 39 mm AK live ammunitions were seized from inside the hayloft located at the eastern side of the farm-house i.e. Lamlai Mamang Leikai Samu Lambel, Imphal East District at about 12:44 p.m. by observing due formalities. On further examination, the arrestee stated that the above seized ammunitions and one hand grenade were handed over to him by one Mr. Naughtyboy @ Naoba of KCP (MFL) group in the month of January, 2026. Recently, on the advice of the said Mr. Naughtyboy @ Naoba of KCP (MFL), he had handed over the Hand grenade to two unknown persons sent by the said Mr. Naughtyboy @ Naoba of KCP (MFL) group and the above seized ammunitions are being kept concealing at the farm house.
