Subject: - Report

Sir,

I have the honour to state that today i.e. 01/03/2026 at about 10:20 am, a reliable information was received from our own source and further corroborated from the information input provided by 33 AR regarding the presence of some active cadres of PREPAK organization, an outlawed banned organization, in and around Phaknung area of Imphal East District with a view to commit prejudicial activities. Based on the information and with the permission of the authority, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri P. Achouba Meetei, MPS, Dy. SP (CDO), IW and under the supervision of Shri. N. Suraj Singh, MPS, Addl. SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area after giving prior information to Imphal East District Police Control Room and conducted search operation at Phaknung Awang Leikai area. During that one suspected person was detained at Phaknung Awang Leikai near ITI for verification. On spot verification, the detainee identified himself as Khundrakpam Anilkumar Singh (21 yrs.) @ Manganglakpa S/o. Kh. Dhanabir Singh of Sawombung Thongkhong, Imphal East District, Manipur.

During preliminary verification, he disclosed that he is an active cadre of PREPAK organization and joined the said organization in the year 2025 through one Malem from Keibi area and got Basic Military Training for 1 month at Chingjao, Kakching District as 58th Batch of PREPAK organization. He also disclosed that he worked under the command of one s/s Commander Tayai @ Romi @ Ningthem and stationed at Wapokpi camp of PREPAK organization for about 8 months under the command of the above mentioned commander.

Hence, he was arrested from the spot i.e. Phaknung Awang Leikai near ITI at 12:06 pm by observing formalities.

From his possession, one Redmi Note 7S mobile handset along with one Jio SIM card bearing mobile no. 9863360586 (as disclosed by him) was seized at the spot at 12:12 pm by observing due formalities.

Hence, the arrested person and the above seized article are handed over to you for taking further necessary legal action against him.
