Subject: FIR against Kuki Militants towards ambush to the civilian passenger vehicles at Roudei (TM Kasom Village) Ukhrul District, Manipur.

Sir,

In the light of peace mission under the initiative of Hon'ble Chief Minister on 17 April, 2026 at Ukhrul, we hope that peace is finally prevailing in Manipur after a prolong civil war in the state. However, our prayer and peace mission was completely pulverize time and again by the Kuki Militant at around 02:10 p.m. at Roudie (TM Kasom Village) where in a private /Passenger vehicle plying from Imphal to Ukhrul, come under heavy attack/ambushed by the Kuki Militants and some vehicles were completely destroyed and unfortunately 2 civilian were killed by the militant apart from several injury to the civilian.

The deceased are namely:-

1. Yaruigam Vashum of Kharasom Village
Son of Thuimi Vashum,
Aged:- 42 yrs. old
He died on the spot.

2. S.W Chinaoshang of Tashar Village
Son of Ruichumhao S.W

Aged:- 45 yrs. old

He sustained injury to the left head and died on the way to Ukhrul.

We demand the concerned Law and order to investigate the incident and hand over the investigation to NIA for fair and justice to the period timely
