First Information contents: Today i.e, on 01.04.2026 at 02:00 a.m, received a reliable information that angry mob numbering around 2000-3000, that was organised aftermath the killing of 4 (Four) cadres of NSCN-IM Eastern Flank allegedly by NSCN-IM at Hongbei village, Kamjong district on 28.03.2026, became unruly and formed into different groups and intruded into the houses reportedly belonging to the leaders of NSCN-IM in Ukhrul town and destroyed the building structures and household properties. The destruction spree was began at around 08:00 p.m. and lasted till 11:00 p.m. of 31.03.2026. The police force deployed in the town could not control the mob as the mob outnumbered far more than the police and scattered to different places/targets. Report received that at least 7 (Seven) houses along with their properties suspected to be belonging to NSCN-IM were destroyed. However, particulars and details of the owners of the destructed houses, the extend of the destruction and approximate value of the properties loss could not be determined at the time of received of the information.

Based on the report, a suo-moto case under **FIR No. 03(04)2026/UKL-PS, U/S 191(2)/324/189/3(5)** BNS is registered and endorsed to ASI, Yokshim Mahak of UKL-PS for investigation.
