Sir,

I have the honour to report that today i.e. the 22nd January, 2026 at about 4:00 p.m. received a reliable information from our own source and further corroborated from the information input provide by 28 AR, 4 Mahar (Borders) and 16 AR regarding the presence of some armed miscreants in general area of Chanung hill range. Based on the information, a combined team led by Inspt. Ch. Dippe, OC-SMG-PS, and myself, a team of Sagolmang PS, one team of CDO/IE, a column of 28 AR, a column of 4 Mahar (Borders) and a column of 16 AR under the command of Inspt. Anilchandra Mutum, OC-Commando Imphal East and under the supervision of Shri Y. Joyraj Singh, MPS Addl. SP(Ops)IE and Shri P. Shankar MPS Addl. SP(L/O)IE and under the overall supervision of Shri. Shivanand Surve, IPS, SP-IE conducted a searched operation at some suspected place of Chanung hill range area about 6:00 p.m. to 7:30 pm. During the search operation, the said combined teams recovered the undernoted articles which were found abandoned at foothill of Chanung hill range suspected to be looted weapons and hidden by unknown miscreants.
