**First Information contents:** Received one endorsement vide Endst. No.1/UKL-PS/2026-SP(UKL)/3942 dated 16/04/2026 from the office of the Superintendent of Police, Ukhrul. The said endorsement pertains to the transfer of Zero FIR originally registered at Lamphel Police Station in connection with the complaint report lodged by Mr. Sowungram Woleng (54 yrs) S/o Wungnaohei Woleng of Sirarakhong Village and presently residing at Hamleikhong C-Block, Ukhrul District near Christian Hospital, Hamleikhong. That, on 31<sup>st</sup> March 2026 at 4:30 pm, unknown mob vandalised his household properties. He has been residing as a tenant in the house of one VS. Atem of Talui Village. The incident happened during his absence of the complainant. The reason for lodging an FIR at Lamphel Police Station was reportedly due to the inconvenience in travelling to Ukhrul from Imphal due to the worsening law and order situation at Litan area. Hence the case.
