Later, in the afternoon of the same day i.e. 07/04/2026 at around 1:45 pm an unruly mob of about 1200 male and female stormed the Lamlai PS Gate Naka Post and vandalized two sentry posts and Barricades manned by personnel of 8th Bihar Regiment.

Hence a Suo-Mottu case under FIR No. 40(4)2026, LLI-PS U/S 191(1)/191(2)/324(4)/221 BNS & 3 PDPP Act has been registered for investigation.
