

I have the honour to report that today i.e. the 24<sup>th</sup> January, 2026 at about 5:00 a.m. received a reliable information from our own source and further corroborated from the information input provided by F/169 regarding the presence of some armed miscreants in general area of Naotrok Hill Range of Chanung.
