Subject : Report.

Sir,

I have the honour to report that today i.e. the 25<sup>th</sup> February, 2026 at about 10:00 p.m. received a reliable information from our own source corroborated with the intelligence of 33 AR about the presence of an active member of the outfit RPF/PLA at Yaingangpokpi area of Imphal-East District, who were attempting to hurl hand grenades targeting to the Central Paramilitary Security personnel deployed at Imphal area. Based on the said information and with the permission/authorization of the authority, teams of CDO/IE Unit conducted a C. I. Ops. at the said area under the command of Shri. Kh. Dhiraj Karan, MPS, Dy. SP(Ops)Imphal East and Inspt. Anilchandra Mutum, Officer-in-Charge CDO/IE Unit, supervised by Shri. Y. Joyraj Singh, Addl. SP(Ops) IE and under the overall supervision of Shri. Shivanand Surve, IPS, Superintendent of Police Imphal East District at 11:00 a.m.

In that, one suspicious unknown person was detained for spot verification at a house at Yaingangpokpi Awang Leikai, Imphal East District. On checking the detainee body, one mobile phone was found and recovered from his possession. On verification, the detainee identified himself as one Thingom Mahenjit Singh @ Anao (22 years) S/o Th. Robindro Singh of Yaingangpokpi Awang Leikai, Imphal East District. On further verification, the detainee stated that he is an active member of the outfit RPF/PLA, joined through one Mr. Dhananjay of RPF/PLA in the month of January, 2026.

So, the detainee was arrested from his residence i.e. Yaingangpokpi Awang Leikai, Imphal East District at 11:38 p.m. and seized, *one mobile phone (Iphone 11) bearing IMEI no. 351082465345141 & 351082465152745 along with one Jio SIM card having phone no. 9863578394* from his possession at the spot i.e. Yaingangpokpi Awang Leikai, Imphal East District at 11:45 p.m. by observing due formalities.

On further verification of the arrestee, he stated that he kept conceal some ammunitions and one detonator at his room, which was handed over to him by one Mr. Pabung of RPF/PLA about one and half months before. On checking the detainee room; (i) 6 (six) nos. of 7.62 x 51 mm SLR live ammunitions, (ii) 3 (three) nos. of .303 live ammunitions, (iii) one 9 mm live ammunitions and (iv) one detonator were seized from underneath the mattress of his bed room of his residence i.e.

Yaingangpokpi Awang Leikai, Imphal East District at 12:19 a.m. of 26/02/2026 by observing due formalities.



Further, on verification of the arrestee, it came to learnt that, yesterday (25/02/2026), he handed over one Hand Grenade to one his associate, namely Ngangbam Derick who is presently residing at Soibam Lekai, Imphal East District to hurl at the personnel of Central Security Forces deployed at Telepati area of Imphal East District. Immediately, our team along with the arrestee rushed to the said house and on the instance of the arrestee (Thingom Mahenjit Singh), one Ngangbam Derick Singh (20 years) S/o Ng. Dhameshwore Singh of Soibam Leikai, Wangkhei Khunou, Porompat Police Station, Imphal East District was arrested from his residence i.e. Wangkhei Khunou, Porompat Police Station, Imphal East District at 2:07 a.m. and seized; (i) *One mobile phone (Redmi Note 8 Pro) bearing IMEI no. 872298040498914 & 862298040498922 along with two SIM card having phone no Jio 6009477453 and Airtel 918413036623* from his possession at the spot i.e. Wangkhei Khunou, Porompat Police Station, Imphal East District at 2:15 a.m. (26/02/2026) by observing due formalities.

On further verification of the second arrestee (Ngangbam Derick Singh), he stated that he joined the said outfit through the first arrestee, Thingom Mahenjit Singh, on 23<sup>rd</sup> February, 2026 and presently working together with him under the command of the said Mr. Pabung of RPF/PLA. He further stated that, yesterday i.e. 25/02/2026 the first arrestee, Thingom Mahenjit Singh, handed over him one hand grenade and advice him to hurl hand grenade at the Security personnel deployed at Telepati area of Imphal-East District. Further, he stated that, yesterday i.e. 25/02/2026 at about 9:30 p.m. he went to Telepati, Imphal East to hurl the hand grenade to the security personnel but he didn't hurl the grenade as he didn't get any chance to do so, since the said area (Telepati, Imphal East District) is strictly guarded and deployed by the State and Central Security personnel. He further stated that, the said hand grenade was kept concealed at the roadside of Ahongei- Soibam Leikai Road near Ahongei Primary School, Imphal East District, so that he may take out and hurl to the security personnel, once he got the opportunity to hurl. Immediately, our combined team along with arrestee rushed to the said place and on the pointing of the second arrestee (Ngangbam Derick Singh), seized one *No. 36 Hand Grenade without detonator* at the spot i.e. roadside of Ahongei- Soibam Leikai Road near Ahongei Primary School, Imphal East District at 2:30 a.m. of 26/02/2026 by observing due formalities.

On further verification of the arrestees, they stated that they are presently working together under the command of the said Mr. Pabung of RPF/PLA and advice them, to hurl hand grenades at Security forces. The first, arrestee (Thingom Mahenjit Singh) stated that, about a months before, he hurl one Hand Grenade to the security personnel at Yaingangpokpi Bazar area on the advice and instruction of the said Mr. Pabung of RPF/PLA.

Therefore, the arrested persons along with the seized items are being handed over to you for taking up further necessary legal actions against them.
