



Today i.e. 12/04/2026 at 12:30 AM, received an information that yesterday i.e. 11/04/2026 at 11:20 pm, a large number of Meira Paibis carrying flaming torches including some male youths totaling about 3000 (three thousand) persons who had come from two different directions i.e. from Lamlai side and Leimakhongmapal side, congregated in front of the residential Gate of Hon'ble MLA Lamlai A/C, Kh. Ibomcha Singh of Nongada Awang Leikai and started protesting against the killings related to Tronglaobi Incident. The protest was supposed to be a peaceful torch rally by the Meira Paibis. However, the protest became violent as the mob started pelting stones towards the residence of the Hon'ble MLA and targeted the police and CAPF personnel deployed there to safeguard the Hon'ble MLA. Therefore, after seeking permission from the Magistrate who was on duty, the police party fired forty(40) rounds of Stunt Shell and three (10) Capsi Grenades to disperse the mob who tried to forcibly proceed towards the residence of Hon'ble MLA. It is also reported that during the protest some protesters received injuries.

Hence, a regular suo-mottu case under FIR No. 42(4)2026, LLI-PS U/s 191(1)/191(2)/61(2)/129/352/195/221/223 BNS has been registered for investigation.
