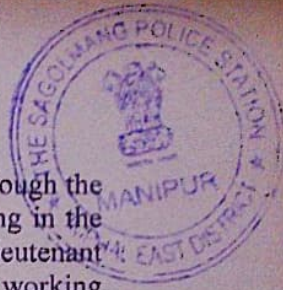

Sir,

I have the honour to report that today i.e., the 1st February, 2026 at about 1:00 p.m. received a reliable information from our own source corroborated with the intelligence of 2 FID ex 3 CIB, 16 AR & 28 AR about the presence of some active members of the outfit KCP at Sagolmang area of Imphal East District. Based on the said information and with the permission/authorization of the authority, a combined team of CDO/IE Unit along with a column of 16 AR & 28 AR conducted a C.I. Ops. at the said area under the command of Inspt. Anilchandra Mutum, Officer-in-Charge CDO/IE Unit, supervised by Shri. Y. Joyraj Singh, Addl. SP(Ops) IE and under the overall supervision of Shri. Shivanand Surve, IPS, Superintendent of Police Imphal East District at 2:00 p.m.

In that, two suspicious persons were detained for spot checking and verification at Happy Valley, Sagolmang, Imphal East District. One checking the detainee bodies, one AADHAR card each were found and recovered from their possession. On verification, the detainee identified themselves as; (i) Ayekpam Robindro Meitei @ Parihan (28 years) S/o (Late) A. Kumar Meitei of Pukhao Naharup Mayai Leikai, Sagolmang Police Station, Imphal East District (ii) Thokchom Abung Singh @ Lanchangba (23 years) S/o Th. Tomchou Singh of Pukhao Naharup Awang Leikai, Sagolmang Police Station, Imphal East District. On further verification, the detainees stated that they are active members of the outfit KCP (Taibangnganba) group. On further verification, the detainee Robindro stated that he joined the outfit through one Mr. Nelson of KCP (Taibangnganba) in



the month of August, 2023. The other detainee (Abung), he stated that he joined the outfit through the first detainee (Robindro) in the month of November, 2024 and got his basic military training in the same year for 30 days at Laingoubi, Bishnupur under the command of one s/s – Second Lieutenant Mr. Rajesh of KCP (Taibangnganba) group. Both the detainees stated that they are presently working under the command of one Mr. Taibangnganba of KCP (Taibangnganba) group.

So, the detainees, **Ayekpam Robindro Meitei & Thokchom Abung Singh** were arrested from the spot i.e. Happy Valley, Sagolmang Police Station, Imphal East District at 2:26 p.m. and 2:30 p.m. respectively. From the possession the arrestees, **Ayekpam Robindro Meitei and Thokchom Abung Singh**, one AADHAR card each were seized from their possession at the spot i.e. Happy Valley, Sagolmang Police Station, Imphal East District at 2:35 p.m. and 2:40 p.m. respectively by observing due formalities.

Therefore, the arrested persons along with the seized AADHAR cards are being handed over to you for taking up further necessary legal actions against them.
