I have the honour to report that today i.e., the 12<sup>th</sup> February, 2026 at about 4:30 a.m. received a reliable information from our own source and further corroborated from the information input provide by 2 FID/3CIB, 28 AR, 16 AR and 4 Mahar (Borders) regarding the presence of some armed miscreants in general area of Champhai Hill Range. Based on the information, a combined team led by Inspt. Ch. Dippe, OC-SMG-PS, and myself, a team of Sagolmang PS, two team of CDO/IE (Oscar 15 & 16), a column of 28 AR, 16 AR and a column of 4 Mahar (Borders) under the command of Smt. Sophia Shintuidang MPS SDPO-LLI and Inspt. Anilchandra Mutum, OC-Commando Imphal East and under the supervision of Shri Y. Joyraj Singh, MPS Addl. SP(Ops)IE, Shri P. Shankar MPS Addl. SP(L/O)IE and under the overall supervision of Shri. Shivanand Surve, IPS, SP-IE conducted a search operation at some suspected place of Champhai Hill Range area about 6:00 a.m. to 7:30 am. During the search operation, the said combined teams recovered the undernoted articles which were found abandoned at Foothill of Champhai Hill Range suspected to be looted weapons and hidden by unknown miscreants.
