**Subject:** Prayer for Registration of Zero FIR regarding the Burning of My Residential Home and Total Destruction of Properties at C. Moljol Village by Suspected Arambai Members.



**Respected Sir,**

I, **Mr. Seipao Khongsai**, aged about 31 years, S/o **Jamthang Khongsai**, a permanent resident of **C. Moljol Village, Island Block, P.O. & P.S.-Andro, District- Kangpokpi, Manipur- 795149**, and presently residing at **T. Champhai Village, P.O. & P.S.-Churachandpur, District- Churachandpur, Manipur - 795128**, respectfully submit this application for registration of a Zero FIR. The facts of my complaint are as follows:

1. **That on 4th May 2023**, following the sudden eruption of widespread ethnic violence across Manipur, the situation in and around my village became extremely unsafe. Due to threats and fear for our lives, I, along with my family, was compelled to flee from C. Moljol Village and take shelter in Churachandpur District for our safety.
2. **That ever since the violence began**, I have remained displaced and unable to return to my native home due to the tense and dangerous environment prevailing in the area.
3. **That on 6th May 2023, at around 4:00 PM**, members of the **Arambai Tenggol** came to my residence at **C. Moljol Village (Place of Occurrence)** and **set my house on fire**, completely burning it down along with all movable properties inside and around the premises.
4. **That I received reliable information regarding this incident only on 18th November 2025**, through villagers and local sources, as I had no access to the area due to ongoing violence, displacement, and the prevailing security situation.
5. **That the said act of arson**, committed by the suspected members of Arambai Tenggol, resulted in the **total destruction of my home, household belongings, clothing, furniture, important documents, essential items, and other valuables**, causing me severe emotional, physical, and financial distress.
6. **That the approximate value of all movable and immovable properties destroyed** in the incident amounts to **Rs. 25,91,500/- (Rupees Twenty-Five Lakh Ninety-One Thousand Five Hundred only)**.
7. **That the delay in submitting this FIR is purely due to unavoidable and compelling circumstances beyond my control.**
8. **That on 4th May 2023**, after fleeing my home, I was forced to take shelter in **Najang Village, Henglep**, which is an extremely remote and inaccessible area, far from Churachandpur Police Station. The village lacks proper transportation, communication facilities, and road connectivity. Due to ongoing instability, fear of further attacks, and absence of safe travel routes, I was unable to reach Churachandpur to lodge the FIR earlier.
9. **That I remained in Najang Village for survival and safety until recently**. Only on 1st November 2025 was I able to relocate and reside at **T. Champhai Village, Churachandpur**, which finally enabled me to approach your office and submit this complaint.
10. **Hence, the delay is unintentional and solely due to displacement, fear, lack of access, and circumstances entirely beyond my control.**
11. **That the above actions constitute serious cognizable offences under the Bharatiya Nyaya Sanhita, 2023 (BNS), including offences relating to arson, mischief by fire, destruction of property, criminal trespass, rioting, unlawful assembly, and other relevant provisions applicable under the new law. As I am displaced and the incident**
