In continuation to the complaint letter No. 2/1/2024/KRO, dated 30/12/2024 of this office, I would like to rectify the previous complaint letter by stating the following few points related to discrepancy in Transit Pass of 4 (four) STP Book.

- i) The STP Book No. 7151 & 7153 was issued under this office while the documents reflected in the letter enclosure of 10 Sector Assam Rifle are not matching with the original one which we issued, thus, it seems like the consignee has copied the department documents, seal and officer signature for generating an inauthentic transit pass by some unknown person.
- ii) I authorised only the staffs posted under this office to issue the said STP i.e Kamjong Range Office which means this STP will have the signature of either me or staffs along with the seal of RFO kamjong.
- iii) The STP Book No. 7154 & 7155 were issued to Phungyar Range while the Transit Pass of the same STP as reflected in the letter enclosure of 10 Sector AR was found using seal & signature of Kamjong Range Office which seems like an inauthentic one.

Therefore, the consignee carrying this 4 (four) STP Book No. during transit are likely inauthentic. Our team has also tried our level best to enquire about this but we are unable to find any culprit behind this act. So, I would like to seek the help of your department and request to file a complaint to further investigate the matter at your level as per the procedure laid down in the law for such cases.




