1. On 26 February 2025, a credible input was received from own sources regarding likely infiltration attempt by insurgents in general area Nampanga Lok River along BP-114 & BP-115. Accordingly two operational columns of 8 AR were launched in said general area respectively to foil the likely infiltration attempt. On 28 Feb 2024, at around 0345 hrs, after establishing an effective double sided Ambush followed by thorough surveillance and domination of the said area, own column detected suspicious movement of two individuals near BP-114 and immediately sprung into action. On challenging the infiltrating individuals, one individual managed to escape towards the Myanmar territory however another individual who was carrying a bag tried to run inside own territory. After hot pursuit, the said individual was apprehended without his bag in general area Kultuk Village near BP-114. Post detailed search of the said area, his bag was found unattended consisting War Like Stores carrying 01 x Pistol, 06 x 9 mm live rounds, 01 x Chinese Grenade, 01 x Radio set and 01 x Mobile Phone. After thorough interrogation of the said individual, it has been revealed that he had erstwhile joined the 10th unit of Aramabai Tenggoul in January 2024 and after having served in the same outfit for around six months, he later joined proscribed UG group PLA in July 2024. In the first week of February 2025, the said individual along with 10 x other PLA cadres were inducted towards general area Homalin, Myanmar for advance military training. On 23 February 2025, he deserted the camp at Homalin and was trying to infiltrate inside Indian territory and was subsequently apprehended by the troops of 8 AR deployed on ground along IMB. 
