Sir,

1. It is intimated that an input was recd from 19 WEU, 11 WEU, 36 EW & other agencies with respect to the move of War like stores and prep of cache along Indo-Myanmar Border and LDP was launched in general area BP 114 to BP 118 with effect from 05 April 2026. Same was converted to Dynamic Temporary Operating Base on 06 April 2026.

2. At approximately 0445 hours on 11 April 2026 Drone Surveillance team reported a suspicious heat signature near BP 115. Immediately, a team with the strength of 01-01-20 was launched at 0455 hours and a team of strength of 01-01-10 with metal detectors was launched at 0455 hours from Dynamic Temporary Operating Base to establish cordon around the suspected site. The initial cordon was established by team A & team B by approximately 0630 hours and search of the suspected site began at 0700 hours.

3. At approximately 1030 hours, the search team found a temporary Bamboo shelter at Grid Reference 115966. Though no individual was spotted in the area, the fresh signature of burnt firewood and daily use items were found. The teams started thorough search the area.

4. At approximately 1230 hours on 11 April 2026, while following the trails, the team with metal detectors and Explosive Detector Dog team confirmed a suspected site. Upon further search, a cache has been found approximately 700 meters South East of temporary hide out at Grid Reference 125959.

5. At approximately 1315 hours, SP Kamjong was informed about the recovery. He asked to bring the recovered items to Kamjong for handing over to police. The team launched in operation Rakong moved from Grid Reference 125959 at 1430 hours for Company Operating Base, Aishi post destruction of temporary hideout. During the search following War Like Stores have been recovered:
