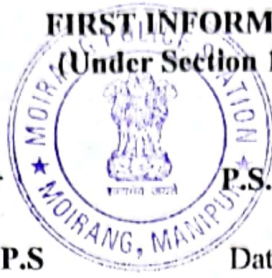

Today i.e. 17/1/2026 at 4.40 pm received a reliable information that on the same day at around 4.35 pm one two wheeler vehicle bearing regd. No. Nil driven by unknown rider which was plying from Moirang Lamkhai toward Moirang Bazar side collided with one Maruti ECO Van bearing regd. No. Nil driven by unknown driver which was plying from opposite direction at Moirang Patlou Leikai along Moirang bazar road and due to rash and negligence driving on the parts of the said both vehicle drivers. As a result of which rider of two wheeler vehicle received injury on his person and evacuated to hospital for medical treatment. Both the vehicle were partly damaged.
