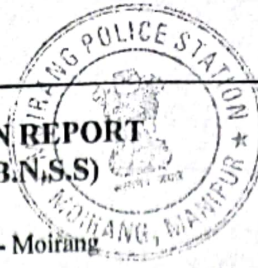

Sir,

I have the honour to report that today i.e. 17/01/2026 at about 03:10 p.m. received specific information from 165 TA and 11 Wireless Tec. by SAFE/TBL (special action force for extortion) that some active cadres of PREPAK, a banned unlawful organisation are loitering in and around Moirang Lamkhai area for prejudicial activities like extortion, monetary demand from valley Districts. Acting on the information, a joint team of Commando Unit Thoubal led by Inspt. K.

Nitaranjan Singh Officer-in-Charge, Commando Unit, Thoubal under the supervision of Shri Hijam Devendra Singh, MPS, Addl. Superintendent of Police (Ops) Thoubal and under the overall supervision of Shri Manoj Prabhakar M, IPS, Superintendent of Police, Thoubal and a column of 31 AR immediately rushed to Moirang Lamkhai area at around 05:00 p.m. after giving necessary information to SP control room Bishnupur and conducted frisking and checking of suspected persons. In that, one person was seen in a very suspicious manner. On his suspicious nature, he was detained for verification.

On preliminary verification he identified himself as Hemam Malem Singh @ Yaisha 22 yrs. s/o. H. Noren Singh of Moirang Oksongbung Mamang Leikai, Bishnupur District, an active member of PREPAK.

On his body search one Jio Bharat key pad mobile handset along with one Jio SIM card bearing mobile No. 8837208292 were recovered from his possession.

On spot verification he disclosed that he joined PREPAK in the month of January, 2024 through one Swamikumar @ Ton of their organisation. He got 45 (forty five) days basic military training at Sawombung, Pourabi, Imphal East District. He is working under the command of s/s. commander Prem of PREPAK. He further disclosed that he provides logistic support to his organisation.

Hence he was arrested at 07:35 p.m. from Moirang Lamkhai near Lake view Hotel and seized the above mentioned Jio Bharat key pad mobile handset along with one Jio SIM card bearing mobile No. 8837208292 at 07:42 p.m. of the same day at the spot from his possession by observing formalities.

It may be mentioned that all the necessary formalities under BNSS i.e. preparation of seizure memo and arrest memo by taking videography and all the documentation works were prepared at the spot at about 08:00 p.m. of the same day and recorded through e-Sakshya portal.

The arrested person mentioned above along with seized articles are being handed over to you for taking further necessary legal action against him.




