Today i.e. 17/1/2026 at 9.30 pm received a reliable information that on the same day at around 9.25 pm one Motor cycle Royal Enfield bearing regd. No. Nil driven by unknown rider and pillion rider which was plying from Moirang Bazar toward Tronglaobi side collided with one Alto Car bearing regd. No. MN04A/2936 driven by unknown driver which was plying from opposite direction at Moirang Okshongbung along NH-2 Tiddim Road and due to rash and negligence driving on the parts of the said both vehicle drivers. As a result of which rider and pillion rider of Motor cycle Royal Enfield vehicle and driver of Alto Car were received injuries on their persons and evacuated to Hospital for medical treatment. The both vehicle were partly damaged.
