Sir,

I have the honour to state that today i.e. 07/02/2026 at about 03:30 pm, a reliable information was received from our own source and further corroborated from the information input provided by 31 AR regarding the presence of some active cadres of PREPAK (Pro) organization (a faction of PREPAK organization), an outlawed banned organization, in and around Kongba area of Imphal East District with a view to commit prejudicial activities. Based on the information and with the permission of the authority, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW assisted by myself under the command of Shri P. Achouba Meetei, MPS, Dy. SP (CDO), IW and under the supervision of Shri. N. Suraj Singh, MPS, Addl. SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area after giving prior information to Imphal East District Police Control Room and conducted search operation at Kongba Nandeibam Leikai area. During that one suspected person was detained at Kongba Nandeibam Leikai Leirak No. 4. On spot verification, the detainee identified himself as Sagolsem Joychandra Singh (47 yrs.) @ Bungcha @ Mayo s/o (L) S. Lokendro Singh of Kakwa Makha Nameirakpam Leikai, Imphal East District, Manipur.

During preliminary verification, he disclosed that he is an active member of PREPAK (Pro) organization (a faction of PREPAK organization) and started working for the said organization since October, 2025 through one s/s Corporal Taibanganba @ Bangamba of PREPAK (Pro) organization from Bamon Leikai area who is presently staying in Myanmar. He also disclosed that he is presently working under the command of the above mentioned s/s Corporal Taibanganba @ Bangamba (Ph. Nos. 8794361424 / 7085117289 / 8131886841) of PREPAK (Pro) organization. He further disclosed that under the instruction of his commander, he was involved in extortion activities by serving monetary demands/threats to general public in valley area for raising their party fund. Further, he disclosed that today i.e. 07/02/2026, his commander instructed him to collect mobile nos. of BSNL employees residing at BSNL quarters located at Palace Compound area to be used in extortion activities.

On further verification, he disclosed that he was also a cadre of RPF/PLA organization and joined the said organization through one Ibethoi (younger sister of one Chaoren of RPF/PLA organization) from Pishum area in the year 1994 and got Basic Military Training for 45 days in Taikotang, Myanmar and was allotted Army No. 1164 (8<sup>th</sup> Batch).

Hence, he was arrested from the spot i.e., Kongba Nandeibam Leikai Leirak No. 4 at 05:06 pm by observing necessary formalities.

From his possession, (i) one Redmi Note 13 5G mobile handset along with one Jio SIM card bearing mobile no. 9366139123 (as disclosed by him), (ii) one brown wallet containing a sum of Rs. 40/- (Rupees forty only) and one Aadhaar card bearing no. 6465 8433 1022 were seized at the spot at 05:13 pm by observing due formalities.

Hence, the arrested person and the above seized articles are handed over to you for taking further necessary legal action against him.


