Sir,

With due respect, I would like to state that I am a permanent resident of Panjang Village. Kangvai Sub- Division, Churachandpur District, Manipur. At the start of prevailing Manipur conflict that started from 03-05-2023, we still stayed at our village as we had the feeling that protection of the village and properties were important. However, with tension getting worse with the passing of time, we had left our village during the first week of August, 2023 for our safety as our village is close to the Meitei localities and we also had the apprehension that one time or the other, our village will be attacked.

That shortly after leaving the village i.e. on 8th August, 2023, our village was attacked by unknown miscreants and our house was vandalized and partially burnt. The wall of our house bear bullet marks. During the subsequent month, we could no longer access to the village as it was extremely dangerous for its vulnerability.

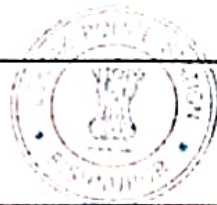
However, I had not filed any FIR regarding the incident as the village chief stated that he had filed an FIR but that could not stand valid for us as our particulars were not mentioned. Another reason for our late registration of FIR is that we were not aware of the importance of filing FIR but now with the Government taking initiative to provide welfare schemes, it is highly necessary to register FIR on our behalf to avail those welfare schemes and benefits provided by the government.

Now, with me leaving with no other option but to put forward my grievances to you registering FIR so that my losses are compensated.
