Sir,

In submitting herewith, the Preliminary Enquiry Report that I have the honour to report that on 06/01/2026 the complt. namely Mutum Dinesh Singh (53) s/o Mutum Iboyaima Singh R/O Heirangoithong Awang Maibam Leikai, Imphal West District reported to OC-IBG-PS stating that he has been running a Petrochemical Godown at Takhok Awang near Kongba Ngariyan Road which is constructed inside a homestead land under Patta No. 277 (old), 601/882 (new) covered by C.S. Dag No. 1002/1488 (Sht.-2) which (the noted land) is taken in Lease for 11(eleven) months w.e.f. 04/11/2025 by him and Mr. Ankit Mishra (38) s/o Ravikant Mishra r/o Sishu Apartment SWS, Ghoramara Tiniali, Bhetapara, Opposite Kali Mandir, Beltola, Kamrup Metro, Assam (as Lessees) from Yumlebham Ibungcha Singh (48) s/o (L) Y. Ibohanbi Singh a resident of Uchekon Takhok Mapal (as Lessor).

On 05/02/2026 at about 4:30 pm, when he along with his wife Santibala came to his godown for routine checking, he found brock open the lock of the godown and stolen the following noted items:

1. Bitumen	-	500 Barrel	value Rs. 57,50,000/-
2. Emulsion	-	56 Barrel	value Rs. 6,72,000/-
Total Value			Rs. 64,22,000/-

He strongly believed that the theft (Crime) has been committed by the Mr. Yumlebham Ibungcha Singh s/o (L) Y. Ibohanbi r/o Uchekon Takhok Mapal which is the caretake of his godown where the abovementioned stolen items are kept for safe custody. He stolen and converted the said numbers of bitumen barrels into in his own use without the consent of the owner of Dinesh Enterprises which is liable under criminal misappropriation of trust. Hence, the Enquiry.

During the course of inquiry examined the complt minutely. On examination he stated that he along with Loushambam Manishana Singh and Moirangthem Mangi Singh have been running a Petrochemical Firm (Dinesh Enterprises) since 20/11/2025 and have a Godown at Takhok Awang near Kongba Ngariyan Road which he took on lessees from the alleged accused person Yumlebham Ibungcha Singh s/o (L) Y. Ibohanbi r/o Uchekon Takhok Mapal. Further, on 27/11/2025 he purchased 500 Barrels of Bitumen and 56 Barrels of Emulsion for Rs. 71,35,010/- from Mascot Peto Products, Beltola Kamrup Metropolitan, Guwahati Assam. On 01/12/2025 the said barrels were kept inside at the said Godown under locked and key. The keys were given to his caretaker i.e. to the alleged accused person Yumlebham Ibungcha Singh. However, on 05/02/2026 he along with his wife Santibala went to his godown for routine checking and found brock open the lock of the godown and 529 barrels were stolen by him. (Y. Ibungcha)

On further inquiry alleged accused person Yumlembam Ibungcha Singh appeared before Police Station and examined minutely in the inquiry. On examination, he admitted that he intentionally steals 500 barrels of Bitumen and 29 barrels of Emulsion without the consent of the owner (complt). Moreover, he admitted that on 04/02/2026, 80 nos. Bitumen Barrels had been sold to Ningombam Babu (64) s/o N. Achou of Thoubal Okram Leikai without the consent of the complaint.

From the enquiry it is established that the alleged accused person Yumlembam Ibungcha Singh (48) s/o (L) Y. Ibohanbi r/o Uchekon Takhok Mapal has committed offence u/s 305(a)/318(4)/314 BNS i.e. theft, cheating and criminal misappropriation of trust. Thus, prima facie evidence has been made out against the alleged accused person for registration of regular case for investigation.

Hence, the above enquiry report is submitted for taking up necessary legal action against Yumlembam Ibungcha Singh under relevant section of law and punished him accordingly.
