I have the honour to state that today i.e. 23/02/2026 @ 10:00 am, a random frisking and checking was conducted at T Khullen Naka Check point by a joint team of SOT (Special Operation team) Senapati Police along with D-78 Bn CRPF, B-109 Bn CRPF Quick Action Team (QAT) & 16 Assam Rifle While conducting frisking and checking, one Bolero White in colour bearing Regn. No. AS01FY-9787 was seen coming from Imphal side towards Senapati. The said vehicle was stopped for frisking and checking. On enquiry, the driver of the vehicle is identified as **Abu Mohammad Tahir (28 Yrs)** s/o Mohammad Martuza Hasan of Khola part -I, Karim Ganj District, Assam-788701. On checking the vehicle, suspected Heroin Powder was found concealed under the rear guard of the vehicle. Following which I have informed to my senior officer. Lhunkhopao Touthang (Executive Magistrate) was deputed for doing the necessary procedures.
