Subject: Complaint Regarding Firing Incident.

Sir,



I have the honour to report that today, i.e., 20/02/2026 at approximately 01:04 hrs, I heard three gunshots fired at the gate of my residence. After about 20 minutes, upon checking the premises, I found that our tin sheet gate had been damaged by bullet impacts.

Furthermore, my vehicle, a Swift ZXI Plus bearing Registration No. MN 01 AX 4349, which was parked inside the garage within the compound, was also found to be severely damaged with multiple bullet holes.

This deliberate act of firing at our residence has caused immense fear, mental distress, and a serious sense of insecurity for me and my family members. The incident appears to be a grave and intentional act that endangered our lives and property.

I strongly request you to kindly take appropriate action to identify and apprehend the culprits involved, and take strict legal action against them under the relevant sections of law.
