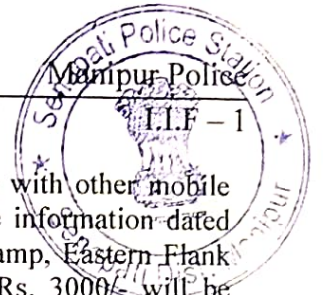

As per endorsed in reference to the above endorsement number, I had conducted an enquiry on the complaint made by Nilotpal Medhi aged about 45 years s/o Rajen Medhi of North Guwahati Rangmahal, Assam present address Satyam Industry, Senapati. That,

- On 26/02/206 at around 2:50 pm, two unidentified persons aged- mid age (40-50 yrs) visited his factory located at Maremei Taphou. They forcibly entered the premises and threatened to kill him and burn down his factory unless he pay them ₹2,00,000 (Rupees Two Lakhs only) immediately. They mentioned they belong to Eastern Flank and pointed Gun towards him and cocked weapon. He got completely frightened. They know everything about his stay, schedule and family, if he don't pay, they will kill him and set his factory on fire." He felt immediate fear for his life and property.
- Subsequently, he received multiple threatening call from mobile No. 7085388233 from the individuals. The caller repeated the same threats: demanding Rs. 2,00,000/- (Two Lakh) warning of his murder and threatening his family and he has preserved the call log/details.
- These acts have caused him severe mental trauma, fear and disruption to his business operations. He apprehended imminent danger to his life and property, as the threats are ongoing and specific as they have weapon which they pointed on me.


