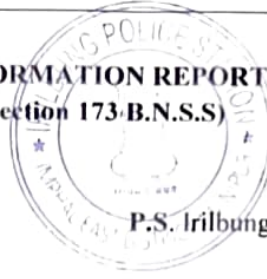

Subject: Report.

Sir,

I am to report that, today, i.e. 26/02/2026 at about 9.15 am, received a reliable intelligence input by Major Rajkumar Sanjeev of 31<sup>st</sup> Assam Rifle, that some suspected armed group are loitering in and around Nongmaijing Ching Forest Range area, Imphal East District to commit prejudicial activities. Immediately, teams of Special CDO unit, Khabeisoi, Manipur assisted by HC. H. Omega Meitei, led by Shri. L. Bebekananda Singh, OC-SPL/CDO Unit, Khabeisoi under the supervision of Dr. S. Ibomcha Singh, IPS, C.O. 6<sup>th</sup> I.R.B. & i/c S.P. Special CDO unit, Khabeisoi by giving prior information to the Imphal East Control Room, rushed to the said area and conducted cordon and search operation at the suspected areas to prevent any unwanted activities.

During the search operation, the team observed suspicious movement at Kalika Lairou Ching area. However, the unknown miscreants managed to escape by taking advantage of the hilly terrain and dense cover of the area.

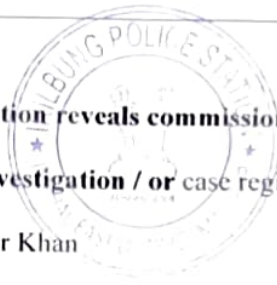
