Today i.e. 29/03/2025 at 09:35 pm received a reliable information that on the same day at about 9:30 pm one I-20 bearing Regd. No. MN01AK-5992., driven by one unknown driver which was proceeding from Bishnupur side towards Nambol side dashed to the backside of Mahindra scorpion bearing Regd. No. MN01G-5231 which was parked on the western portion of Tiddim road at Oinam near Tanglei gas agency due to rash and negligent driving on the part of both the unknown drivers of involved vehicles. As a result of which the unknown driver of the Mahindra scorpion and I-20 received sustained injuries on their persons and evacuated to hospital for medical treatment. And both the vehicles were also badly damaged.
