Today, i.e. the 1<sup>st</sup> March, 2026 at 7:10 pm received a telephonic information that on the same day at about 6:40 pm at Kongba Kshetri Leikai near entrance way of Royal Academy of Science one pedestrian was knocked down by a Honda Activa bearing registration No. MN06SX-2225 which was coming from Kongba Bazar side towards Irilbung side along Imphal Ngariyan Road due to rash or negligent driving on the part of the unknown rider of the Honda Activa. As a result of which the pedestrian received serious injury on his person and evacuated into Raj Medicity, North AOC for medical treatment. Both the Honda Active rider and pillion rider received minor injury of their person and evacuated into JNIMS Hospital, Porompat for their medical treatment. The Honda Activa also got partly damaged.

Hence, a regular suo motu case under FIR No. 18(3)2026 IBG-PS u/s 281/125(b)/324 BNS, 2023 was registered at this Police Station for further investigation.
