12. First Information contents:

Today i.e. 14/04/2025 at around 10:00 pm two teams of Nambol P.S. led by me and another led by SI. Y. Arunkumar Singh was conducting regular mobile patrolling under Nambol PS jurisdiction as a preventive measure in c/w Goura Cheiraoba Festival, 2025. On reaching at Bamdiar Ahallup found one vendor (Meat Hotel) and while checking 05 (five) dogs were found concealed inside 05 (five) different sacks in his vendor. The owner of the said vendor was identified as one Ningthoujam Suran Singh aged about 34 years S/o N. Suresh Singh of Bamdiar Ahallup Makha Leikai, PO & PS- Nambol, Imphal West District, Manipur. Accordingly, he was arrested at 10:30 pm by observing necessary formalities from his vendor. Further, he disclosed that the dogs were bought from his localities using his vehicle and to be cook and sold at his vendor. As, there is no facility or expertise in the police station, help from People for Animals Manipur (an animal welfare organization) was sought for rescue and handling of the case property animals. Accordingly, a team of animal handlers from the organization rescued the dogs. Then, the dogs were seized at 10:50 pm by observing all due formalities. The arrested person could not produce any documents/ bills/receipt relating to buying the said dogs, and it is highly suspected that all the dogs might be stolen. Then the arrested person along with all the dogs were brought at the PS for further necessary action. Hence, a regular case under FIR No. 21(04)2025 NBL-PS u/s 317(5)/325 BNS, 11(1)(a)(d)(e)(k) PCA. Act is registered on suo moto for investigation.
